Effective June 15, 2011 the SAS 70 report was replaced by the SSAE 16 (SOC 1). In addition the AICPA introduced new service organization control reporting options. The new SOC 2 and 3 reports are designed to better address the report on controls relevant to security, availability, processing integrity, confidentiality, or privacy. This session will include refresher information on the nature of the 3 SOC reports, 'real world' examples/applications of the new reports, and lessons learned this first year from both a client and audit firm perspective. In addition the session will include suggestions on how to read / use the reports as well as opportunity for attendees to share their impressions and experiences.

Rod Walsh provides leadership for BKD's SOC efforts. He has more than 30 years of experience and provides services in security and risk management, SOC examinations and readiness engagements, IT control reviews, Health Insurance Portability and Accountability Act (HIPAA) program assessments and system selection and acquisition consulting.
