Speakers: Bryan McGowan, KPMG and Reggie Hair, Sprint Corporation

Bryan McGowan is a Director in KPMG's Advisory practice. Over the last 10 years, Bryan has consulted with a number of companies on business continuity (BC) and disaster recovery (DR). Specifically, Bryan has designed business continuity governance frameworks, testing strategies, conducted business impact analyses, and developed business continuity, disaster recovery, and crisis management plans. Prior to joining KPMG, Bryan worked in the Technology Planning organization at SBC Services (now part of AT&T) and assisted in the development, testing, and roll out of the enterprise IT disaster recovery plan.

Reggie Hair is the Manager of the Business Continuity Office at Sprint Corporation. He has 10 years' experience as a leader of the enterprise Business Continuity program and leader of the enterprise incident management structure. Reggie leads a team that is responsible for facilitating enterprise process change, training and exercising cross-functional teams and executives and establishing direction, goal and objectives for the company BC program.
