

**PRIVACY POLICY**  
**Greater Kansas City Chapter of ISACA**

This Privacy Policy describes how the Greater Kansas City Chapter of ISACA (“ISACA KC Chapter”) collects, uses, shares, and retains personally identifiable information you provide. The Policy is effective as of March 15, 2012. The policy was last modified on March 11, 2012. This Privacy Policy applies only to information collected by the ISACA KC Chapter (“we” or “us”) at <http://www.isaca-kc.org> (the “Site”). It does not apply to information collected or used by ISACA International (“ISACA”) web sites, including ([www.isaca.org](http://www.isaca.org), for the ISACA International Privacy Policy, please visit <http://www.isaca.org/pages/Privacy.aspx>). This Privacy Policy also does not cover the practices of ISACA Chapter business partners (such as vendors, sponsors, or advertisers), nor does it apply to personally identifiable information that we collect from or about our consultants, contractors, vendors, sponsors, or advertisers.

**Modifications to this Policy**

From time to time, the ISACA KC Chapter may need to update or modify this Privacy Policy. When this occurs, the ISACA KC Chapter will notify you of any material changes to the Privacy Policy via email. We will also post the most recent version of the Privacy Policy and information about the changes from the previous version on the ISACA KC Chapter web site.

**International Visitors**

If you are providing personally identifiable information and are not a resident of the United States, your country’s laws governing data collection and use may differ from those in the United States, in particular, the U.S. may not provide the same level of protections as those in your own country. By providing information to the ISACA KC Chapter, you are transferring your personal data to the United States, and you consent to the transfer to, retention of and processing of your data in the United States.

**Collection of Personally Identifiable Information**

The ISACA KC Chapter collects and maintains a variety of personally identifiable information, including First Names, Last Names, Email Addresses, and Company Names, as well as demographic information, such as training courses or presentation topics of which you may be interested. The ISACA KC Chapter collects this information directly from you through online chapter meeting and training course registration forms, as well as both online and offline programs surveys. This Information is collected and maintained from chapter members, event attendees, speakers, participants in ISACA KC chapter programs, survey respondents, and others. To the extent that information requested is not required for your participation in a given ISACA KC Chapter program, you will be told which information is optional.

The ISACA KC Chapter may also maintain information about you that you do not directly provide, such as which chapter events you have attended, which boards and committees you have served on, and which chapter offices you have held.

**Passive Online Data Collection**

The ISACA KC Chapter does not now, but may in the future, collect certain information passively, such as online non-identifying information through the use of cookies technology and/or Internet Protocol (“IP”) address tracking. Non-personal identification information might include the browser used by you, the type of computer, the operating systems, the Internet service providers, and other similar information.

On the ISACA KC Chapter Site, there may be certain third-party advertisers whose advertisements contain cookies that collect data from you. Some of those cookies may contain tracking mechanisms that observe your behavior across multiple Sites. The ISACA KC Chapter does not control the use of cookies by advertisers or third parties displaying data on the Site or on the sites you visit using links from the Site.

**Use, Sharing and Retention of Personally Identifiable Information**

The ISACA KC Chapter uses personally identifiable information for the purposes described at the time of collection or as otherwise described to you in order to process your requests; to report to others about whether you are certified or not; distribute chapter communications via email; or register you for event or training programs. The ISACA KC Chapter does not sell or otherwise transfer or disclose personally identifiable information to third parties not affiliated with the ISACA KC Chapter without your prior consent.

The ISACA KC Chapter may share personally identifiable information with affiliated third parties for legitimate business purposes, including for the following reasons or in the following circumstances:

- To vendors or third-parties who deliver or provide goods and services or otherwise act on behalf of or at the direction of the ISACA KC Chapter, which third parties include, for example, training providers and partners, third-party event hosts, other third parties who may provide services on web sites that are accessible from links on our Site, and credit card companies processing payment;
- To the ISACA KC Chapter volunteers and board members in order to perform their duties on behalf of the Chapter;
- To ISACA and the IT Governance Institute;
- To investigate potentially fraudulent or questionable activities;
- When we believe it is necessary to cooperate with law enforcement or in response to a government request, including if specifically requested or required, as otherwise permitted by law, and for other valid business purposes of the ISACA KC Chapter.

The ISACA KC Chapter retains personally identifiable information for as long as necessary for its legitimate business purposes, and as otherwise permitted by applicable law.

**Security**

The ISACA KC Chapter uses reasonable measures to safeguard sensitive personally identifiable information you provide to us through the Site. However, we cannot guarantee that your information will remain secure. The Internet by its nature is a public forum, and the ISACA KC Chapter encourages you to use caution when disclosing information online.

**Links to Third-Party Sites**

From time to time, the ISACA KC Chapter Site may provide links to third-party web sites, or advertisements that contain links to third-party sites. For example, the ISACA KC Chapter uses a third party service in order to process payments for chapter meetings and training seminars. We may also provide links to third parties that provide online training services. These links are provided as a service to you. These sites are operated by independent entities that have their own privacy policies. The ISACA KC Chapter's Privacy Policy does not apply to such other sites or to the use that those entities make of your information. The ISACA KC Chapter has no control over the content displayed on such sites, nor over the measures, if any, that are taken by such sites to protect the privacy of your information.
